The direct conversation with you *did happen*. It was the OCA call on March 17 attended by multiple individuals on this thread.

In that conversation, *Rebecca* was the one who raised the issue of a perceived lack of trust, stemming from The Weedaker Group not partnering with OCA. *In response to Rebecca*, Jamie raised the concern of OCA's relationship with New Approach and asked for clarity. There was no ambush, and Rebecca was given space to provide transparency and demonstrate good faith.

During that call, Rebecca shared that you two were each compensated \$7000 per month for your work for OCA and *to strenuously deny an OCA connection to New Approach*. Rebecca said OCA was funded by Heroic Hearts, *as opposed to New Approach*, and that she got involved related to her relationship with Jesse Gould. She said this to everyone on the call.

Rebecca's assertions about OCA's relationship to New Approach, which she made on the March 17 OCA call, were false, as you just confirmed: "the idea and funding for a community org originated in collaboration with New Approach."

Nothing I claimed in this thread has been disputed with evidence.

Hello all,

We have talked over and over (and over) our response to these emails.

Unfortunately, all our responses cannot overcome our anger, frustration and hurt at these accusations and the way they came about.

We are only responding now to the entire chain to refute certain points:

1. Although the idea and funding for a community org originated in collaboration with New Approach, once created, Open Circle Alliance operated with its own distinct objectives - which from the start, were not primarily concerned with the passage of Q4. The org has always had independent decision making and continues to operate in this manner. Any perception that we were trying to hide our relationship to New Approach was an unfortunate misunderstanding of us trying to demonstrate clear separation. One that ideally could have been cleared up with direct conversations with us (which did not happen).
2. While disagreements over funders and approaches to the work are natural sources of conflict and misunderstanding in advocacy, accusations about rate of pay and efficacy are personal attacks. They have been received that way by us. We will not be responding to or further engaging with these insulting claims. Further, they seem to be an extension of the dissatisfaction with how New Approach decided to spend its money, which makes us completely the wrong targets for this critique.

We are considering our place in the community and how to move forward. If any of you have any other questions or responses, we ask that you come directly to us and not belabor this email chain.

I think a cooling off period is appropriate, but I'm not a liar. In addition to my contemporaneous notes on the 12/18/24 Chacruna panel, in which Stefanie claimed the genesis of Open Circle Alliance was Jared Moffat of New Approach having a conversation with her in early 2024 and disclosing a problem to be solved (disunity of MA psychedelics community), then subsequently introducing her to Emily Oneschuk and Rebecca Slater to solve it, attached are the 2/21/24 texts I referred to.

In inquiring as to the individual Emily Oneschuk led me to believe might be hired to be "a new campaign director," Jared clarifies that "Emily was probably thinking of Stefanie." He goes on to note she has not been hired (yet) and would not be overseeing the *whole* campaign. Why would Emily "probably be thinking of Stefanie" as a possible campaign director for the campaign if Stefanie was not already closely affiliated with the campaign or those running it?

In a conversation over the phone, Jared told me about his/New Approach's vision for Open Circle Alliance as part of the campaign/movement, which led me to compliment his "innovative model." Jared replied by saying he was "Excited to put all this into motion."

As Jamie referenced, there is extensive internal documentation of Open Circle Alliance's close collaboration with the campaign and, of course, Emily Oneschuk was campaign staff while simultaneously co-founding OCA! But I decided to throw in a few, relatively innocuous, May 2024 texts, with Jared alluding to Stefanie's role in de facto campaign outreach.

During the 12/18/24 panel, Stefanie identified educating people about the ballot question as one of Open Circle Alliance's core goals, along with bringing the psychedelics community in MA together. She also confirmed OCA held just 5 events in 8 months (apparently counting 1 post-election event and the May 2024 soft-launch event) to accomplish those goals (so only 4 that could help ballot measure).

Who would be incentivized, in 2024, to put \$200,000+ into a new organization to 1. unite the psychedelics community in MA specifically (problem identified by Jared Moffat per Stefanie) and 2. educate the public about the psychedelics ballot question? Presumably: the same donors/kinds of donors who funded the formal campaign/New Approach.

Why would Heroic Hearts take money that could go to saving veterans' lives and give it to an organization, staffed primarily by non-veterans, to unite MA's psychedelics community? Heroic Hearts prioritizing MA's psychedelic community over veterans seems like a stretch to me.

If I get *anything* wrong, it is unintentional, and I welcome clarity.

Truthfulness and accuracy are both incredibly important to me, and I know my email was both of those things, so I would love to discuss further what you feel might be incorrect in anything I said in my email specifically (and would request documentation, as I provided). Even though I'm not the one to address Graham's personal opinions, I would be happy to address/verify the facts he highlighted, or talk about this further with anyone interested, but would ask that we all try to do so as civilly and drama free as possible.

Rebecca, I want to chime in and provide additional clarity. Stefanie publicly said Jared Moffat of New Approach came to her with the idea for Open Circle Alliance during her December 18, 2024 Chacruna panel, which aligns with what Jared told me dating all the way back to the beginning of 2024.

I have a text from Jared from February 21, 2024, referring to Stefanie being brought onboard. The same day, I thank him over text for "coming up with this innovative model" referring to Open Circle Alliance. Jared told me he/New Approach was fundraising for Open Circle Alliance and that he was involved with the proposal of an organization to replace Bay Staters for Natural Medicine. Emily Oneschuk gave me a similar explanation about the origins of the organization. Jared had initially pitched *me* to join Open Circle Alliance rather than the campaign.

Of course, Jamie and I are not sure what your mandate was from donors. We were led to believe that Open Circle Alliance was going to help with outreach/public education above and beyond what could be done by unpaid volunteers. This outreach and public education never materialized. OCA held 3, small public events targeted toward existing supporters in Cambridge and Boston during the campaign. EMC held the same # of events, albeit with a successful focus on expanding the movement to better include people of color.

I speculate that OCA was intended to help with development. It is no secret, Rebecca, that you are very well-networked with high net worth individuals. However, the ballot measure campaign's fundraising was anemic for most of the year.

Early in 2024, Emily Oneschuk stopped being a full-time organizer, leaving the campaign's outreach even more severely understaffed and underfunded than it already was, since Emily, Jamie, and I comprised the grassroots outreach team and only Emily was intended to be full-time. Jamie Morey was hired to run campaign events but given an event budget of only \$2500 *for the entire campaign*. For a substantial period, I was the campaign's *only* full-time staff member. I was paid \$36,200, excluding expenses, for everything I did. CJ LoConte was paid \$0 for his *extensive service* on behalf of the campaign, including being featured in most of the campaign advertisements

on TV and digital, being featured in high-profile media coverage such as in the *Boston Globe*, participating in the *Boston Globe* editorial meeting, and publicly debating the opposition.

In comparison, you and Stefanie were each paid full-time salaries. OCA received \$7000 for a *single event*, the launch party, as compared to Jamie's \$2500 for *all campaign events*. And, being frank, we don't see the work. And, considering neither you nor Stefanie mention OCA in your LinkedIn histories or bios, perhaps you don't either. *OCA is still not a registered 501c3 despite hundreds of thousands of dollars of funding*. OCA's board is smaller and less impressive than SPAN's, which was spun up in far less time than OCA had. OCA got less media coverage in 2024 than EMC.

We don't see the signs of good faith effort to help the ecosystem. To my knowledge, OCA has not made any introductions to donors for ANY of the grassroots organizers on these calls, which would be most helpful given how well-networked you and Stefanie are. You cannot provide credible mentorship in operating orgs like SPAN, Mass Healing, EMC because you don't have a record of accomplishment in the space.

You shouldn't be surprised that there is distrust from advocates who busted their asses as volunteers to make plant medicine accessible while you and Stefanie seemed to be overpaid by a deep-pocketed super-PAC to do very little *and* keep it a secret.

I've had nice interpersonal interactions with both you and Stefanie, and I wanted Open Circle Alliance to succeed. But this dynamic is not working and is not sustainable.

Unless Open Circle Alliance can adopt radical honesty and transparency about how the money was spent, from whom, and for what in terms of its activities so far, it's going to be impossible for the org to be accepted.

In follow up from our conversation yesterday, I wanted to further expand on the lack of trust issue and be direct with you. I know firsthand from multiple conversations with Jared that New Approach created Open Circle with a stated goal of engaging and educating the community to support the ballot question. Regardless of the fact that the money for your substantial part time salaries (and I assume additional operating costs which you haven't yet disclosed) came through Heroic Hearts, this doesn't change the fact that Open Circle was created by and for New Approach. To say otherwise is not truthful.

Open Circle Alliance was repeatedly untruthful with the community at large, by attempting to appear completely separate and uninvolved with the Yes on 4 campaign, when that was not the case. The statement below appears on all of the fact sheets on OCA's website:

However, even though you and Stefanie eventually did try to publicly distance yourself from the campaign as the months went on, Open Circle was absolutely and undeniably associated with the campaign, and the two of you were on regular New Approach/Dewey Square Group meetings organized by Jared for the purposes of "coordinating outreach and coalition building," as evidenced by the two emails below (and many others).

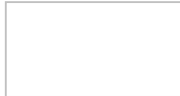

I was thinking about how to engage scientists like Haley Dourron without forcing them to become public advocates. What kind of carrots could we give them? How can we platform them apart from inviting them to testify, privately consulting with them, etc.?

And then it occurred to me the new nonprofit could have a scientific advisory board or boards. So, for example, it could even have a scientific advisory board dedicated solely to mitigating risks of psychedelics, for example. And there could be some overlap: some scientists could be on multiple boards.

Basically, you could have a great answer to critics like the MPS heads because when Dr. Fromson says, "What about pregnant women and women of reproductive age?", we could say, "We have an entire scientific advisory board dedicated to psychedelics and pregnancy!" When Dr. Ghaemi says, "What about drug interactions?" We could say, "We have an entire scientific advisory board dedicated to addressing the risks of unknown drug interactions!"

You wouldn't have to compensate people for participation on these boards. Scientists would be rewarded with the credential, the publicity, and related networking and career opportunities, particularly being invited to advise and work for psychedelics-related companies, nonprofits, state regulatory bodies, etc.

And the nonprofit could have non-scientific advisory boards as well, which would function similarly but not be filled exclusively with scientific researchers. These boards could address things like spiritual use of psychedelics, etc.

We could have an advisory board dedicated to every facet of the psychedelics issue, cultivating a deep bench of expertise to inform policy worldwide. And all these advisory board positions would give us a bunch of carrots to reward and incentivize experts embracing legalization.

Then, whenever Emily, Jared, Rebecca, Graham, etc. meets an expert who we really click with, whose ideas and/or research is awesome, we can invite them onto an advisory board! They have an express route into the party. :)

Veterans - If the goal is for me to connect the campaign with veterans, get letter of support signed, engage the veteran community to attend a public attend next month, and turn out for the election, it would be helpful to get some press and social media coverage to reach a wider audience so that veterans like CJ will see it and reach out to get involved. I wanted to reach out to the social media team about potential content on upcoming awareness days/weeks/months, including national overdose day and recovery month coming up, but if this is something the campaign is intentionally shying away from, would like to know/discuss that

Events - I have people offering to put together community events, so wanting to discuss the approval/funding process for that and any guidelines (such as would you want to avoid a learn to grow event) so we can start putting things on the calendar.

Stickers - Want to circle back on this with timing info to see what makes sense

Feedback - would love to briefly revisit the comment you made during our last call about feeling like I was complaining, picking apart the campaign, etc. which is not my intention. I care deeply about this cause and want to do what I can to improve things and I'm feeling like my feedback isn't necessarily welcome at this point

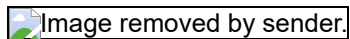

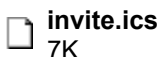
